

MINUTES OF REGULAR MEETING OF THE BOARD OF TRUSTEES OF RECLAMATION DISTRICT NO. 1600

Monday, September 9, 2024 @ 3:00 PM

Call to Order: Clark called the meeting to order at 3:03 pm.

Public Comment on Non-Agenda Items None

Financial Statements Prepared by Dustin Dumars, CPA

Statements sent via email by Dumars prior to the meeting. Dumars described the statements and recommended that the District consider moving funds from the Yolo County Treasury to Raymond James to earn a higher yield. Trustees agreed, and Clark will discuss it with Eric Hoffert, Raymond James adviser. Dumars explained the move to bill.com for payment of District invoices.

Dumars left the meeting.

Upper Elkhorn - Moving Yolo Bypass Levee Project

Gregg Ellis, (ICF consultants) and Chris Campbell (cbec consultants) explained their role as part of the Technical Team to the Steering Committee on the Upper Elkhorn Planning Project. They described the proposed changes to the Tule Canal and used schematics to demonstrate three alternatives: Water Supply and Drainage Alternative, Small Tule Canal Alternative and Large Tule Canal Alternative. They acknowledged that the cost and funding of the operations and maintenance of the Tule Canal following any changes is still an unexplored, noting that all is conceptual at this point. Campbell noted the Tule Canal conveyance is limited to 1000 cfs. Trustees asked questions about each of the alternatives and impact on the drainage problems anticipated from each. Trustees explained current seepage in the District and in the Lower Elkhorn and belief that ponding water in the Yolo Bypass will exacerbate the seepage, potentially making farming in the District less productive and/or economically unviable.

Synder, Ellis, Campbell left the meeting.

Report by MBK Engineers on Maintenance and Related Matters

Anderson provided information on each of the following items:

- a. USACE Yolo Bypass Repair work is scheduled for October; 100% funded by USACE.
- b. DWR Deferred Maintenance Program (DMP) replacement of the gravity pipe to be funded 100% by DWR \$1,606,300 Motion by Yeung, second by Reyes, unanimous approval of motion to accept the funds and enter into the agreement Resolution 2024-9-1
- c. Flood Maintenance Assistance Program (FMAP)
 - 2024: \$138,000.00
 Landslide Levee Slope Repair completed by ASTA –
 paid \$14,037.38; Anderson is working with Dumars office on allocating funds for completed work. Yeung to get grazing invoice from McGrew.
 - 2025: Authorize making & accepting grant funds Motion by Yeung, second by Reyes, unanimous approval of motion to accept the funds and enter into the agreement. – Resolution 2024-9-2
- d. Update on Vegetation Control <u>Discussion on on-going vegetation</u> control projects.
- e. **COMPLETED** Flood System Repair Program (FSRP) for RD1600 patrol roadway repair
 - Work completed for total price of \$394,672.25 –
 State's share = \$355,205.03. District's share = \$39,467.23
 - ASTA Construction paid majority of invoice; balance to be paid when 10% retention is funded by State
- f. COMPLETED DWR-Funded RD 1600 Roadway Repair
 - Work completed for total price of \$484,906.10; ASTA Construction paid
 - Access License with DWR expired 6.30.2024
 - Anderson has seen rilling and will follow up with DWR.
- g. FEMA Payment for 2023 Flood matter turned over to CAL OES still waiting for payment **Anderson continues to explore.**

- Yeung informed the Trustees the Elkhorn Fire Station was closed by the County. RD537 is interested in acquiring the property and using it to store new equipment they intend to purchase. Bill Mattos suggested RD1600 could join RD537 in those acquisitions. Following discussion, the Trustees unanimously agreed that RD1600 is not interested in partnering with RD537 on this.
