### **AUTHORIZING REMOTE MEETINGS PURSUANT TO AB 361**

**WHEREAS**, Reclamation District No. 1600 is committed to preserving public access and participation in meetings of the Board of Trustees; and

**WHEREAS**, all meetings of the District are open and public, as required by the Ralph M. Brown Act (Gov. Code, §§ 54950 – 54963) ("Brown Act"), so that any member of the public may attend, participate, and watch the District's legislative body conduct its business; and

WHEREAS, Assembly Bill 361 added Government Code section 54953(e) to make provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

**WHEREAS**, those conditions currently exist within the District, namely, that the District is included within the March 4, 2020 state of emergency declared by the Governor pursuant to Government Code section 8625, and that state or local officials have imposed or recommended measures to promote social distancing.

## NOW, THEREFORE, THE BOARD OF TRUSTEES OF RECLAMATION DISTRICT NO. 1600 DOES HEREBY RESOLVE AS FOLLOWS:

- 1. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.
- 2. Remote Teleconference Meetings. The District shall conduct its meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953. District staff are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution, including conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.
